This Release of Security Interest in Trademarks (this "Release") is intended to operate as a release of all liens and security interests conveyed by Company to Administrative Agent pursuant to the terms of the IPSA, and to reassign to Company all of Administrative Agent's right, title, and interest acquired pursuant to the terms of such IPSA, in each case without any representation, warranty, recourse or undertaking by Administrative Agent.
