**ASSIGNMENT OF INTELLECTUAL PROPERTY
SECURITY AGREEMENT**

This ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Assignment”), dated as of March 24 2023, is by CITIBANK, N.A., as the current and resigning administrative agent (in such capacity, the “Existing Agent”) and JPMORGAN CHASE BANK, N.A., as the successor administrative agent (in such capacity, the “Successor Agent”) under that certain Credit Agreement, dated as of February 25, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Original Credit Agreement”, and as amended and restated as of the date hereof, the “Credit Agreement”).

RECITALS:

WHEREAS, Etsy, Inc., a Delaware corporation and Reverb.com, LLC, an Illinois limited liability company (collectively the “Grantors” and each a “Grantor”), and the Existing Agent are parties to those certain intellectual property security agreements identified on Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, amended and restated, supplemented or otherwise modified from time to time, collectively, the “Agreements”), which granted a security interest in the Patents, Trademarks and Copyrights identified on Exhibit B attached hereto to the Existing Agent; and



