TRADEMARK AND DOMAIN ASSIGNMENT AGREEMENT

NOW, THEREFORE, BE IT KNOWN, pursuant to this Agreement, Assignor has conveyed, assigned, transferred, delivered and set over to Assignee, its successors and assigns, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, all right, title and interest in and to any and all (i) trademark rights and copyrights throughout the world, including any and all applications, registrations, and common law marks, together with the goodwill, domain names, and any other intellectual property of the business associated with and symbolized by same, held by Assignor immediately prior to the consummation of the transactions contemplated by the General Assignment, including those set forth in **Schedule A** hereto, together with all common law rights therein and the right to sue for past infringement of any and all of said trademarks, and (ii) the Assigned Domains, including without limitation any and all registrations, applications, and/or common law rights for the Assigned Domains throughout the world, together with all of the goodwill of Assignor’s business symbolized by or associated with the Assigned Domains, and any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto including, without limitation, damages and payments for past, present or future infringements.
