Pursuant to Title 6, Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "Act")

Borrego Energy, LLC, a Delaware limited liability company (the "Company"), does hereby certify to the following facts relating to the merger (the "Merger") of Borrego Solar Systems, Inc., a California corporation ("Borrego"), with and into the Company, with the Company continuing as the surviving limited liability company of the Merger:

FIRST: The name and state of formation or organization of each of the constituent company in the Merger (the "Constituent Companies") are as follows:

SECOND: The Agreement and Plan of Merger, dated as of May 24, 2022, as amended by the First Amendment, dated as of July 26, 2022 (the "Merger Agreement"), by and among Borrego, New Leaf Energy, Inc. (formerly known as 2022 Solar Development, Inc.), a Delaware corporation, and the Company has been approved, adopted, certified, executed and acknowledged by each of the Constituent Companies pursuant to and in accordance with Section 18-209 of the Act.

THIRD: The name of the surviving limited liability company (the "Surviving Company") of the Merger shall be **Borrego Energy, LLC**.

FOURTH: The Certificate of Formation of the Surviving Company shall be the Certificate of Formation of the Company, until thereafter amended as provided therein or by applicable law.

FIFTH: An executed copy of the Merger Agreement is on file at the principal place of business of the Surviving Company at 5005 Texas Street, Suite 400, San Diego, CA 92108.

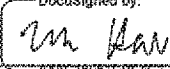
SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Company, on request and without cost, to any stockholder of Borrego or any member of the Company.
