UA Connected Fitness, Inc. a corporation organized and existing under the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify as follows:

1. The Corporation's original Certificate of Incorporation was filed with the Delaware Secretary of State on May 6, 2009.
2. A Certificate of Merger was filed with the Delaware Secretary of State on December 27, 2016, pursuant to which the Fourth Amended and Restated Certificate of Incorporation of the Corporation (the "Fourth A&R COI") was amended to change the name of the Corporation to UA Connected Fitness, Inc.
3. ARTICLE 1 of the Fourth A&R COI is hereby further amended and restated in its entirety to read as follows:  
"The name of the corporation is MyFitnessPal, Inc. (the "Corporation")."
4. Such amendment was duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
