TRADEMARK SECURITY AGREEMENT dated as of March 27, 2023 (this “Agreement”), by and between VGW Luckyland Inc., a Delaware corporation (the “Borrower” or, the “Grantor”) and Brigade Agency Services LLC as administrative agent for the Lenders and as collateral agent and security trustee for the Secured Parties (in such capacities, together with its successors and assigns in such capacities, the “Administrative Agent”).

Reference is made to (a) that certain Credit Agreement, dated as of March 20, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among the Borrower, Parentco, the Lenders party from time to time thereto and the Administrative Agent, and (b) that certain U.S. Pledge and Security Agreement, dated as of March 27, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “U.S. Security Agreement”), by and among the Borrower, the other grantors from time to time party thereto and the Administrative Agent.

Whereas, the Lenders have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement.

Whereas, the Grantor is willing to execute and deliver this Agreement in order to induce the Lenders to make the Term Loans.

Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the U.S. Security Agreement or the Credit Agreement, as applicable. The rules of construction specified in Section 1.2 of the U.S. Security Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment and performance in full of the Secured Obligations, the Grantor hereby grants to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a first lien security interest (the “Security Interest”) in all of the Grantor’s right, title and interest in, to and under any Trademarks and Trademark Licenses now owned or at any time hereafter acquired by the Grantor, including those listed on Schedule I, and all Proceeds thereof (the “Trademark Collateral”); provided that the Trademark Collateral shall exclude all Excluded Assets.

SECTION 3. U.S. Security Agreement. The Security Interest granted to the Administrative Agent, for the benefit of the Secured Parties, herein is granted in furtherance, and not in limitation, of the security interests granted to the Administrative Agent, for the benefit of the Secured Parties, pursuant to the U.S. Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the Trademark Collateral are more fully set forth in the U.S. Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the U.S. Security Agreement, the terms of the U.S. Security Agreement shall govern.

SECTION 4. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original

but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Agreement by facsimile or other electronic transmission (i.e. a “pdf” or “tif” document) shall be effective as delivery of a manually signed counterpart of this Agreement.

SECTION 5. Electronic Execution The words “execution,” “execute”, “signed,” “signature,” and words of like import in or related to this Agreement and any document to be signed in connection with this Agreement shall be deemed to include electronic signatures, the electronic matching of assignment terms and contract formations on electronic platforms approved by the Administrative Agent, or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable Law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state Laws based on the Uniform Electronic Transactions Act.
