**ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY
COLLATERAL**

This ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Assignment"), dated as of March 22, 2023, is entered into by and between JEFFERIES FINANCE LLC ("Assignor") and APOLLO ADMINISTRATIVE AGENCY LLC ("Assignee"). All capitalized terms used herein and not otherwise defined shall have the respective meanings given to such terms in the applicable IP Security Agreement, whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain Security Agreement, dated as of October 15, 2018 (as may have been amended, modified or supplemented from time to time, the "Security Agreement") among R.R. DONNELLEY & SONS COMPANY, CONSOLIDATED GRAPHICS, INC., BANTA CORPORATION, PBM GRAPHICS, INC., PRECISION DIALOGUE, INC. (each a "Grantor", and collectively the "Grantors"), Assignor, and certain other parties, one or more of the Grantors executed and delivered in favor of Assignor (i) a Patent Security Agreement, dated October 15, 2018, which was recorded in the United States Patent and Trademark Office ("USPTO") on October 17, 2018 at Reel/Frame 047245/0245; (ii) a Patent Security Agreement, dated April 30, 2021, which was recorded in the USPTO on May 3, 2021 at Reel/Frame 056122/0839; (iii) a Patent Security Agreement, dated February 25, 2022, which was recorded in the USPTO on February 25, 2022 at Reel/Frame 059104/0374 (iv) a Trademark Security Agreement, dated October 15, 2021, which was recorded in the USPTO on October 17, 2018 at Reel/Frame 6459/0001; (v) a Trademark Security Agreement, dated March 29, 2019 which was recorded in the USPTO on April 1, 2019 at Reel/Frame 6605/0297; (vi) a Trademark Security Agreement, dated April 30, 2021, which was recorded in the USPTO on May 3, 2021 at Reel/Frame 7278/0590; (vii) a Trademark Security Agreement, dated February 25, 2022, which was recorded in the USPTO on February 25, 2022 at Reel/Frame 7643/0770 (viii) a Copyright Security Agreement, dated October 15, 2018, which was recorded in the United States Copyright Office ("USCO") on October 18, 2018 at Vol. 9963, Doc. No. 298 and (ix) a Copyright Security Agreement, dated April 30, 2021, which was recorded in the USCO on May 5, 2021 at Vol. 9984, Doc. No. 154 (each a "IP Security Agreement" and collectively the "IP Security Agreements");

WHEREAS, pursuant to the Security Agreement and the IP Security Agreements, each Grantor pledged and granted to Assignor for the benefit of the Secured Parties a lien on and security interest in (the "Security Interest") all of its right, title and interest in, to and under the Patent Collateral, the Trademark Collateral, and the Copyright Collateral, including the Patents listed on Schedule I hereto, the Trademarks listed on Schedule II hereto, and the Copyrights and Intellectual Property Licenses listed on Schedule III hereto (collectively, the "IP Collateral");

WHEREAS, pursuant to that certain Agency Resignation, Appointment and Assumption Agreement, dated as of March 22, 2023, Assignor resigned as Administrative Agent and was succeeded by Assignee, and in furtherance thereof Assignor granted, assigned, transferred and conveyed to Assignee, and assignee assumed, the Security Interest in the IP Collateral.

WHEREAS, Assignor and Assignee desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the USPTO and USCO;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby grants, assigns, transfers and conveys to Assignee, and Assignee hereby assumes, all of Assignor's right, title and interest in, to and under, the IP Collateral and the IP Security Agreements, including, without limitation, its Security Interest in Grantor's right, title and interest in, to and under the IP Collateral. The foregoing assignment is made without representations or warranties of any kind.

This Assignment may be in the form of an electronic record and may be executed using electronic signatures (including, without limitation, facsimile, tif and .pdf) and shall be considered an original. For purposes hereof, the words "execution," "execute," "executed," "signed," "signature" and words of like import shall be deemed to include electronic signatures, the electronic matching of assignment terms and contract formulations on electronic platforms, or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act. This Assignment may be executed in as many counterparts as necessary or convenient, including both paper and electronic counterparts, but all such counterparts are one and the same Assignment. For the avoidance of doubt, the authorization under this paragraph may include, without limitation, use or acceptance by the Administrative Agent of a manually signed paper communication which has been converted into electronic form (such as scanned into PDF format), or an electronically signed communication converted into another format, for transmission, delivery and/or retention.

SECTION 7. Governing Law. This Assignment and the transactions contemplated hereby, and all disputes between the parties under or relating to this Assignment or the facts or circumstances leading to its execution, whether in contract, tort or otherwise, shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.


