ARTICLE 1- DEFINITIONS

The following terms as used in this Agreement shall have the meanings set forth below:

"Acquired Assets" means

- (a) the Trademarks as set forth in Schedule A,
- b) any and all of Seller's worldwide right, title and interest in the Intellectual Property as of the Closing Date,
- (c) the Documentation, within the United States, as described in Schedule B, and all legal rights and privileges belonging or accruing to the owner or holder of such applications.
- d) Goodwill

"Trademarks" means the trademarks and trademark registrations for the Product as set forth in Schedule A.

"Trademark" means any one of the Trademarks. The Trademark shown on Schedule A as being currently registered in the USA is referred to hereinafter as the "USA TRADEMARK."

PURCHASE AND SALE

Purchase and Sale.

On and subject to the terms and conditions set forth in this Agreement, Seller agrees to sell, convey, assign and transfer to Purchaser and Purchaser agrees to purchase, on the Closing Date, all of Seller's right, title and interest in and to the Acquired Assets, subject only to Seller's retained right to use any information within the Acquired Assets to the extent it relates to the Excluded Assets or to Excluded Liabilities or to any products hereinafter developed by Seller.

Assumption of Liabilities.

On the terms and subject to the conditions of this Agreement, the Purchaser agrees to assume the Assumed Liabilities.

The parties understand and agree that Purchaser does not and should not assume or become liable for any liabilities, obligations, commitments or debts related to the Acquired Assets and arising from the sale, purchase, consumption, or use of Product sold by Seller prior to the Closing Date.


Purchase Price.



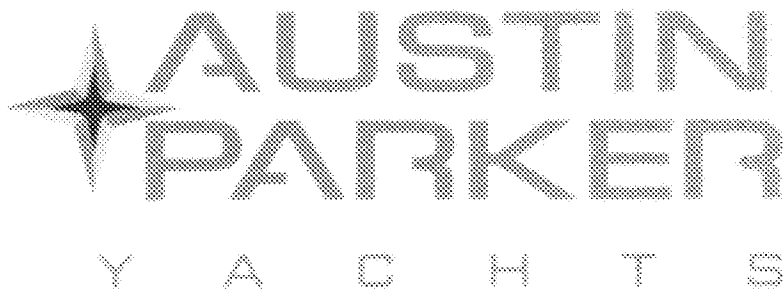
