Assignor further agrees to execute any additional documents as may be reasonably necessary or desirable to confirm the assignment of the Trademarks to Assignee without charge, provided, however, that all additional costs of preparing and recording such additional documents shall be borne by Assignee.

Assignor represents and warrants that it is the exclusive owner of all right, title and interest in and to the Trademarks, has no knowledge as to any liens, encumbrances, claims and assignments with respect to the Trademarks, and has the authority to assign its rights to the Trademarks to Assignee.
