CONFIRMATORY ASSIGNMENT AGREEMENT

THIS CONFIRMATORY ASSIGNMENT AGREEMENT (this “Confirmatory Assignment”) is effective as of January 4, 2023 (the “Effective Date”), by and among HPT TA Properties Trust, a Maryland real estate investment trust, HPT TA Properties LLC, a Maryland limited liability company, and Service Properties Trust, a Maryland real estate investment trust (collectively, “Assignors”), and HPT TRS Inc., a Maryland corporation (“Assignee”).

WITNESSETH

WHEREAS, Assignors and Assignee are parties to that certain Contribution Agreement (the “Agreement”), dated as of January 4, 2023, pursuant to which Assignors assigned to Assignee, and Assignee accepted and assumed from Assignors, all of Assignors’ worldwide right, title and interest in and to certain Trademarks (as such term is defined in the Agreement) and all goodwill related thereto, including, without limitation, those certain trademarks, service marks, and corresponding trademark registrations and applications identified on Schedule 1 attached hereto, other than the portion of the Trademarks and goodwill relating to hotel, motel, or other lodging facility services and activities, as contemplated by Sections 856(d)(9)(D)(ii)-(iii) or 856(1)(3)(B) of the Internal Revenue Code of 1986, as amended (such assigned assets, collectively, the “Assigned Assets”); and

WHEREAS, pursuant to Section 5.1 of the Agreement, Assignors and Assignee have agreed to execute and deliver this Confirmatory Assignment to confirm and evidence of record the distributions and contribution of the Assigned Assets from Assignors to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee agree as follows:

1. Assignors hereby assign, convey, transfer and deliver to Assignee all right, title and interest in and to the Assigned Assets, together with the goodwill of the business symbolized by and associated with the Assigned Assets, the right to secure all renewals and extensions thereof, and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in conjunction with, any and all past, present or future infringement, misappropriation or dilution of or damage or injury to the Assigned Assets or the accompanying goodwill. Assignors hereby acknowledge and agree that from and after the Effective Date, Assignee shall be the exclusive owner of the Assigned Assets and associated goodwill.

2. This Confirmatory Assignment shall be binding upon, and inure to the benefit of, Assignors and Assignee and their respective successors and assigns.


