WHEREAS, Assignor is the owner of the trademarks and the associated trademark registrations set forth on Schedule A attached hereto (hereinafter the “Marks”).



WHEREAS Assignee is a successor to that portion of the business of Assignor to which the Marks pertain and such business is ongoing and existing.


