

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the lien and security interest evidenced by that certain Trademark Security Agreement dated as of December 11, 2020 (the "Trademark Security Agreement"), made by **RHYTHMLINK INTERNATIONAL, LLC**, a South Carolina limited liability company ("Grantor"), having its chief executive office at 1140 First Street South, Columbia, South Carolina 29209, in favor of **MADISON CAPITAL FUNDING LLC**, in its capacity as agent for all Lenders ("Retiring Agent"), which was duly recorded on February 12, 2021, at Reel/Frame 7190/0939 in the Trademark Division of the United States Patent and Trademark Office, which Trademark Security Agreement was subsequently assigned by the Retiring Agent to **APOGEM CAPITAL LLC**, in its capacity as the successor administrative agent ("Successor Agent"), having its chief executive office at 227 West Monroe Street, Suite 5400, Chicago, Illinois 60606, as evidenced by that certain Assignment of Intellectual Property Security Agreements dated as of April 1, 2022 and duly recorded on April 11, 2022 at Reel/Frame 7688/0014 in the Trademark Division of the United States Patent and Trademark Office, and any other right, title or interest granted to the Successor Agent in the Trademark Collateral (as defined in the Trademark Security Agreement), including in the trademarks set forth on Schedule 1 attached hereto is hereby terminated, cancelled, discharged and released, without representation or warranty, and the Agent hereby re-transfers, re-conveys and re-assigns to the Grantor any right, title or interest it may have in or to any of the Trademark Collateral, including the trademarks set forth on Schedule 1. The Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this release. This release shall be governed by, and construed in accordance with, the laws of the State of New York.
