## TERMINATION OF TRADEMARK SECURITY AGREEMENT

United States Patent and Trademark Office

Ladies and Gentlemen:

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the lien and security interest evidenced by that certain Trademark Security Agreement dated March 16, 2022, made by **PRISYMID LIMITED**, a company established under the laws of England, with its registered address at Tech House 13 Oaklands Business Centre, Oaklands Park, Wokingham, Berkshire, England, RG41 2FD, registration no. 05004963 ("Grantor"), in favor of **BARINGS FINANCE LLC**, in its capacity as administrative agent for the ratable benefit of the Lenders ("Administrative Agent"), having an office located at 300 S. Tryon Street, Suite 2500, Charlotte, North Carolina 28202 (the "Trademark Security Agreement"), which was duly recorded on March 16, 2022, at Reel/Frame 7661/0611 in the Trademark Division of the United States Patent and Trademark Office, and any other right, title or interest granted to the Administrative Agent in the Trademark Collateral (as defined in the Trademark Security Agreement), including in the Trademarks and Trademark Licenses set forth on Schedule 1 attached hereto is hereby terminated, cancelled, discharged and released, without representation or warranty, and the Administrative Agent hereby re-transfers, re-conveys and re-assigns to the Grantor any right, title or interest it may have in or to any of the Trademark Collateral, including the Trademarks and Trademark Licenses set forth on Schedule 1. The Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this release. This release shall be governed by, and construed in accordance with, the laws of the State of New York.
