**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “Release”) is dated as of February 28, 2023 and delivered by ALLY BANK, AS COLLATERAL AGENT for the Secured Parties under the Security Agreement referred to below (in such capacity, the “Collateral Agent”) in favor of Vertex Aerospace Services Corp., a Delaware corporation, Vertex Aerospace, LLC, a Delaware limited liability company, Vectrus Systems Corporation, a Delaware corporation, Advantor Systems, LLC, a Delaware limited liability company, Delex Systems, Incorporated, a Virginia corporation, Zenetex LLC, a Virginia limited liability company, and Higgins, Hermansen, Banikas, LLC, a Nevada limited liability company (collectively, the “Grantors” and each individually, a “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below) or the applicable IP Security Agreement (as defined below).

WHEREAS, pursuant to that certain Security Agreement, dated as of June 29, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among, VERTEX AEROSPACE INTERMEDIATE LLC, a Delaware limited liability company, the Grantors, the Collateral Agent and the other parties thereto, in order to secure payments of certain Secured Obligations, the Grantors were required to execute and deliver that certain Intellectual Property Security Agreement, dated as of June 29, 2018 (the “2018 IP Security Agreement”), that certain Intellectual Property Agreement Supplement, dated as of December 6, 2021 (the “2021 IP Supplement”) and that certain Intellectual Property Security Agreement, dated as of July 5, 2022 (the “2022 Security Agreement” and together with the 2018 IP Security Agreement and the 2021 IP Supplement, the “IP Security Agreements” and each an “IP Security Agreement”) pursuant thereto each applicable Grantor collaterally assigned, pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in and to all of such Grantor’s right, title and interest in and to the Collateral and Additional Collateral (each as defined in each applicable IP Security Agreement), including without limitation those (i) Trademarks listed on Schedule I hereto, (ii) Patents listed on Schedule II hereto, and (iii) Copyrights listed on Schedule III hereto.

WHEREAS, pursuant to the 2018 IP Security Agreement, a security interest in certain Trademarks was recorded with the United States Patent and Trademark Office on July 2, 2018, at Reel 6369 Frame 0393.

WHEREAS, pursuant to the 2021 IP Supplement, a security interest in certain Trademarks was recorded with the United States Patent and Trademark Office on December 10, 2021, at Reel 7525 Frame 0701.

WHEREAS, pursuant to the 2021 IP Supplement, a security interest in certain Patents was recorded with the United States Patent and Trademark Office on December 10, 2021, at Reel 058957 Frame 0428.

WHEREAS, pursuant to the 2022 IP Security Agreement, a security interest in certain Trademarks was recorded with the United States Patent and Trademark Office on July 6, 2022, at Reel 7772 Frame 0010.

WHEREAS, pursuant to the 2022 IP Security Agreement, a security interest in certain Patents was recorded with the United States Patent and Trademark Office on July 6, 2022, at Reel 060592 Frame 0786.

WHEREAS, pursuant to the 2022 IP Security Agreement, a security interest in certain Copyrights was recorded with the United States Copyright Office on July 11, 2022, at Volume 15008 Doc. No. 283.

WHEREAS, the Collateral Agent acknowledges the full payment and performance of the Secured Obligations, and as a result desires to terminate and release the entirety of any security interest it may have in the Collateral and Additional Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of itself and the Secured Parties, hereby fully terminates, releases, cancels and forever discharges any and all security interests it has in the Collateral and Additional Collateral, terminates each IP Security Agreement, and retransfers, re-conveys and reassigns to the Grantors, as applicable, and without representation or warranty of any kind, express or implied, free and clear of any claims by the Collateral Agent, all right, title or interest of the Collateral Agent (if any) in, to or under the Collateral and Additional Collateral. The Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office and the United States Copyright Office note and record this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.




