Trademark Assignment Agreement

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is dated as of September 28, 2018, by and between McKesson Financial Holdings Unlimited Company, an unlimited liability company incorporated under the laws of Ireland and with its principal place of business in Bermuda ("Assignor"), and McKesson Pharmacy Systems LLC, a Delaware limited liability company ("Assignee").

WHEREAS, in connection with the Purchase and Sale Agreement, Assignor desires to assign the Assigned Trademarks to Assignee.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby irrevocably sells, assigns, transfers, conveys and delivers unto Assignee all of Assignor's right, title and interest in, to and under the Assigned Trademarks, together with the goodwill of the business associated with the Assigned Trademarks, and all rights to sue or recover and retain damages and costs and attorney's fees for past, present and future misappropriation.

2. NO WARRANTIES. THE ASSIGNED TRADEMARKS ARE BEING ASSIGNED AND TRANSFERRED ON AN "AS IS" BASIS WITHOUT REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, OF ANY KIND, INCLUDING WITH RESPECT TO OWNERSHIP, VALIDITY, ENFORCEABILITY OR NON-INFRINGEMENT OF ANY THIRD PARTY INTELLECTUAL PROPERTY RIGHTS.

3. Counterparts. This Assignment may be executed in any number of counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

4. Governing Law. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Delaware, without reference to any conflicts of laws principles.
