RELEASE OF SECURITY INTEREST
IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of March 29, 2023 (this “Release”) is made by WESTERN ALLIANCE BANK, as Agent, whose address is 2700 W. For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent hereby releases, terminates and discharges its security interest in and to the Released Trademarks and the goodwill associated therewith, without representation or warranty of any kind, express or implied, and hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, all of the Agent’s right, title and interest in and to the Trademark Collateral, including without limitation the Released Trademarks.


