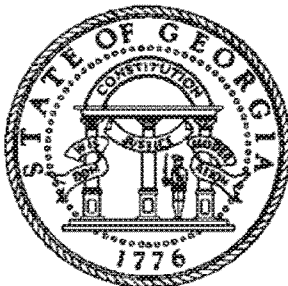

**ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION
OF
TBC-WRIGHT CONSULTING, LLC**

TBC-Wright Consulting, LLC, a Georgia limited liability company, amends its Articles of Organization, pursuant to §14-11-210 of the Georgia Limited Liability Company Act, as follows:

I.

The name of the limited liability company is **TBC-Wright Consulting, LLC**.

II.

The date the articles of organization were filed is December 31, 2004.

III.

The Limited Liability Company hereby adopts the following amendment to change the name of the organization. The Articles of Organization are amended by the deletion of the existing first sentence of Article I, and by substituting the following therefor:
