EXECUTION VERSION

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** (“Agreement”) is made and entered into as of 30 September 2022 by and between MAIDMETAL LIMITED, a private limited company registered in England and Wales with registered number 03264730 and whose registered office is at 9-13 St. Andrew Street, London, EC4A 3AF (“Assignor”) and STAR RECEIVABLES LIMITED, a private limited company registered in England and Wales with registered number 14310989 and whose registered office is at 9-13 St. Andrew Street, London, EC4A 3AF (“Assignee”).

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement relating to Got Talent, dated as of 30 September 2022 (the “Asset Purchase Agreement”), pursuant to which, on the terms and subject to the conditions set forth therein, Assignee agreed to purchase, among other things, all of Assignor’s interests in and to the Got Talent Format and all rights and assets related thereto and associated therewith, throughout the world, including without limitation the Got Talent Assets, the Got Talent IP, the Got Talent Products and the IP Benefits, and further including without limitation a fifty percent (50%) undivided interest in and to the trademark and copyright registrations and applications listed on Schedule A hereto (collectively, the “Assigned IP”). Capitalized terms used but not defined herein shall have the meanings given to such terms in the Asset Purchase Agreement;

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor desires to assign, transfer, convey and deliver to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor’s right, title and interest in, to and under the Assigned IP and all goodwill associated therewith or symbolized thereby.

NOW, THEREFORE, in order to formally memorialize and evidence such agreement, in consideration of the foregoing and the covenants and agreements herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignee and Assignor do hereby agree as follows:

1. Assignment. Assignor hereby irrevocably sells, transfers, assigns, bequeaths, grants, conveys and delivers to Assignee, and the Assignee’s successors and assigns, and Assignee hereby accepts, Assignor’s entire right, title and interest in, to and under the Assigned IP, including without limitation an undivided fifty percent (50%) interest in, to and under each of the trademark and copyright registrations and applications set forth on Schedule A, any and all United States common law rights thereto and therein, as well as the goodwill of the business symbolized by the foregoing; all renewals, reversions or extensions thereof; any and all trademarks, service marks or copyright registrations which may be issued under laws of the United States in the future based on any pending applications; and all rights in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto, all causes of action (whether in law or in equity) with respect thereto, the right to sue (including for damages and injunctive relief), counterclaim, and recover for past, present and future infringement, misappropriation, violation or other unauthorized use of the rights assigned or to be assigned under this Agreement; and all proceeds of the foregoing. Such assignment shall be for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns and other legal representatives. For the sake of clarity, it is confirmed that

the other fifty percent (50%) undivided interest in, to and under the Assigned IP is owned by FremantleMedia North America, Inc. and/or its subsidiaries or affiliates.

2. Cooperation. Assignor shall, at Assignor's expense, timely take all actions and prepare, execute, deliver, file and record all documents that Assignee may reasonably request to effect the terms, intent and purposes of this Agreement and to evidence, record, memorialize or perfect Assignee's title in, to and under the Assigned IP as set forth herein.
3. Recordation. Assignor shall be responsible for the preparation, execution, delivery, filing and recordation of such additional documents that may be reasonably necessary to register, record or perfect Assignee's right, title and interest in, to and under the Assigned IP and for any and all costs, expenses and fees associated with the registration, recordation or perfection of the sale, conveyance, transfer and assignment to Assignee of the Assigned IP at all relevant offices, bureaus, registrars and organizations including without limitation the United States Patent and Trademark Office ("USPTO") and the United States Copyright Office ("USCO"), as applicable. Assignor hereby authorizes the Director of Patents and Trademarks in the USPTO and the Director of Copyrights in the USCO to each record Assignee as the assignee and owner of a fifty percent (50%) undivided interest in and to the Assigned IP, and to deliver to Assignee and to Assignee's attorneys, agents, representatives, successors or assigns, all official documents and communications as may be warranted by this Agreement.
4. Power of Attorney. If Assignee is unable for any reason to secure Assignor's performance of Assignor's obligations under Section 2 or 3 hereof, Assignor hereby irrevocably designates and appoints Assignee, and Assignee's duly authorized officers, agents and representatives, as Assignor's agents and attorneys-in-fact with full power of substitution to act for and on the behalf and instead of Assignor, to perform such obligations and all other lawfully permitted acts to effect the terms, purposes and intent of this Agreement with the same legal force and effect as if executed or performed by Assignor. Such designation and appointment is irrevocable and coupled with an interest. Assignor shall not enter into any agreement in conflict with this Agreement.
5. Governing Law. This Agreement shall be construed, performed and enforced in accordance with, and governed by, the laws of the State of New York (without giving effect to the principles of conflicts of laws thereof).
6. Counterparts. This Agreement may be executed in two or more counterparts, all of which shall be considered one and the same agreement and shall become effective when counterparts have been signed by each party and delivered to each other party. In the event that any signature is delivered by facsimile transmission or by an e-mail which contains a portable document format (.pdf) file of an executed signature page, such signature page shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such signature page were an original thereof.
