**TERMINATION AND RELEASE OF
TRADEMARKS**

THIS TERMINATION AND RELEASE OF TRADEMARKS (“Release”) is made as of March 17, 2023, by WhiteHorse Capital Management, LLC, in its capacity as Collateral Agent (“Agent”), in favor of Stella & Chewy’s LLC, a Delaware limited liability company (the “Grantor”).

WHEREAS, the Grantor entered into a certain Grant of Security Interest in Trademarks with Agent, dated December 16, 2020 (the “IP Security Agreement”), notice of which was recorded with the United States Patent and Trademark Office on February 1, 2021, at reel/frame 7165/0990. Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the IP Security Agreement, a security interest in favor of Agent, in and to all of its right, title and interest in and to the trademarks, which include without limitation the trademarks and corresponding registrations and applications listed in Schedule 1.

WHEREAS, Agent has agreed to terminate and release all of its security interests and liens in all such trademarks as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges all of its security interests and liens in the trademarks, which include the trademarks, registrations and applications listed on the schedules attached hereto and made a part hereof, and assigns, transfers and conveys to Grantor any interest in such trademarks, including the security interests.

If and to the extent the Agent has acquired any right, title or interest in, to or under any of the trademarks, without any representation, recourse or undertaking by the Agent, it hereby irrevocably reassigns and retransfers all such right, title and interest to the Grantor.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereto.
