## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of March 29, 2023, by OCEAN II PLO LLC, a California limited liability company, in its capacity as administrative agent and collateral agent for Lenders (in such capacity, “Agent”) in favor of SOVRN HOLIDNGS, INC., a Delaware corporation (“Grantor”) with its principal place of business located at 5541 Central Avenue, Boulder, CO 80301.

### Recital

WHEREAS, Grantor and Agent are parties to that certain Intellectual Property Security Agreement, dated as of July 12, 2021 (the “IP Security Agreement”) and recorded with the U.S. Patent and Trademark Office at Reel Number 7352 and Frame Number 0580 on July 12, 2021, pursuant to which Grantor granted to Agent, for the ratable benefit of Lenders, a security interest in all of the Grantor’s right, title and interest in, to and under the Intellectual Property Collateral (as defined in the IP Security Agreement, including the Intellectual Property Collateral described on Exhibit A attached hereto, the “Intellectual Property”).

WHEREAS, Grantor has requested and Agent has agreed to release its security interest in all right, title and interest in, to and under the Intellectual Property and terminate the IP Security Agreement.

### Agreement

Now, therefore, Agent hereby terminates and releases, without warranty or recourse, its security interest in all right, title and interest in, to and under the Intellectual Property, terminates the IP Security Agreement, and transfers and reassigns to Grantor, without warranty or recourse, any and all right, title and interest of Agent in the Intellectual Property.


