Worldwide, except for Crimea Region (incl. Sevastopol and as defined by the U.S. Government), Cuba, Iran, North Korea and Syria (the “**Territory**”).

2. Licensed Products

Men, women and unisex fragrances (i.e. perfume, eau de perfume, eau de toilette and cologne); shower gel, body lotion, body cream, body spray, body wash, deodorant, anti-perspirant; makeup and cosmetics; skin and body care; soap and shaving products; home fragrances and candles bearing the Trademarks.

3. Term

The License Agreement is effective as of July 1, 2022 until December 31, 2032. The License Agreement may be renewed from January 1, 2033 until December 31, 2037, subject to separate agreements between Licensors and Licensee on the terms and conditions applicable to such potential extension of the License Agreement.

4. Recordal of the License Agreement

Licensors shall not request the cancellation of the recordal of the license granted to it in the competent trademark registries made pursuant to the License Agreement except in the event the License Agreement is expired or terminated.

5. Assignment
