CONFIRMATORY ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Assignment of Security Interest in Intellectual Property (this "Assignment") is made as of March 28, 2023, by and from Bayerische Landesbank (the "Assignor") with an address at Brienner Strasse 18, Munich, 80333, Germany to and in favor of The Governor and Company of the Bank of Ireland, an Irish company (the "Assignee") with an address at Baggot Plaza (Floor 3A), 27-33 Baggot Street Upper, Dublin 4, Republic of Ireland.

Recital

WHEREAS, Assignor as security agent under that certain Patent and Trademark Security Agreement dated as of December 19, 2016 (the "PTSA") was granted a security interest in the patent listed on Exhibit A attached hereto (the "Patent") and the trademarks and the goodwill of the business in connection therewith listed on Exhibit B attached hereto (the "Trademarks", collectively with the Patent, the "Intellectual Property"), which Patent is issued or pending with the United States Patent and Trademark Office (the "USPTO"), and which Trademarks are registered with the USPTO;

WHEREAS, the USPTO recorded the PTSA on December 21, 2016 (i) with respect to the Trademarks at reel/frame 5940/0744 and (ii) with respect to the Patent at 040695/0100;

WHEREAS, Assignor and Assignee, among others, have entered into that certain Security Agency Transfer Agreement dated as of March 28, 2023 (as amended from time to time, the "Replacement Agreement") pursuant to which Assignee has replaced Assignor as security agent under the PTSA; and

WHEREAS, Assignor has requested and Assignee has agreed to enter into this Agreement to effectuate the Replacement Agreement.

Agreement

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Definitions: All capitalized terms not defined herein shall have the respective meaning given to them in the Replacement Agreement.
2. Assignment of Security Interest:
 - (a) The Assignor hereby assigns to Assignee the security interest in all of Assignor's right, title and interest in and to, as security agent, Intellectual Property attached hereto.
 - (b) The rights and remedies of Assignee with respect to the security interest assigned herein are without prejudice to and are in addition to those set forth in the Replacement Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Assignment are deemed to conflict with the Replacement Agreement or the PTSA, the provisions of the Replacement Agreement or the PTSA, as applicable, shall govern.
3. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.
4. This Agreement may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument. This Agreement shall become effective with respect to the Assignor and the Assignee when the Assignee shall receive counterparts hereof executed by itself and the Assignor. This Agreement may be transmitted and/or signed by facsimile or Adobe PDF file and if so transmitted or signed, shall, subject to requirements of law, have the same force and effect as a manually signed original and shall be binding on the Assignor and the Assignee.


