Termination of Security Interest

THIS TERMINATION OF SECURITY INTEREST (this "Termination"), dated as of January 7, 2021, is executed by FIFTH THIRD BANK, NATIONAL ASSOCIATION fka FIFTH THIRD BANK, an Ohio banking corporation ("Lender") in favor of SATURDAY KNIGHT, LTD., a Kentucky corporation (the "Company").

A. To secure the payment, performance, and observance of the Obligations owing to Lender, the Company granted to Lender its interest, pursuant to that certain Grant of Security Interest in Trademarks executed by the Company in favor of the Lender and recorded with the United States Patent and Trademark Office (the "USPTO") on September 19, 1988, at Reel/Frame: 0617/0261 (the "Trademark Security Agreement"), in the Collateral described therein, including, but not limited to, the trademarks, trademark registrations, trademark applications, and trademark licenses set forth on Schedule 1 annexed to this Termination and made part of this Termination for all purposes (such Collateral, the "Trademark Collateral").

B. The Lender now wishes to terminate the security interest in the Trademark Collateral.

C. All capitalized terms used herein not otherwise defined herein have the meanings given to them in the Credit Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Lender, without representation, warranty, or recourse, hereby:


1. terminates the Trademark Security Agreement;
2. terminates, cancels, discharges and releases any and all liens on and its security interest in and to the Trademark Collateral arising under the Trademark Security Agreement, including, but not limited to, the trademarks, trademark registrations, trademark applications, and trademark licenses set forth on Schedule 1 annexed to this Termination; and
3. authorizes the recordation of this Termination with the USPTO at the Company's expense.

THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF ILLINOIS WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES.
