**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of March 31, 2023, by **BANK OF MONTREAL**, a Canada chartered bank (“Collateral Agent”) in favor of **AGROFRESH INC.**, an Illinois corporation with an address at One Washington Square, 510-530 Walnut Street, Philadelphia, Pennsylvania 19106 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated July 27, 2020 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded by the United States Patent and Trademark Office on July 27, 2020 at Reel 7008, Frame 0410.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing Security Interest in favor of the Collateral Agent, in all of its right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in **Schedule 1**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) the Security Interest in such Trademark Collateral.
