RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of March 31, 2023, by EICF AGENT LLC, as agent (in such capacity, together with its successors and permitted assigns in such capacity, “Agent”) for the Lenders. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Volta Charging, LLC (“Grantor”) and Agent are parties to (i) that certain Trademark Security Agreement, dated as of July 3, 2019 (as amended, restated, supplemented or otherwise modified, the “Trademark Security Agreement”), (ii) that certain Notice of Grant of Security Interest in Trademarks, dated as of October 3, 2022 (the “2022 Notice of Grant of Security Interest in Trademarks”) and (iii) that certain Notice of Grant of Security Interest in Trademarks, dated as of February 15, 2023 (the “2023 Notice of Grant of Security Interest in Trademarks”) pursuant to which Grantor granted to Agent a lien on and security interest in, to and under the Trademark Collateral as security for certain obligations owing by Grantor to Agent;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 8, 2019, at Reel 6688, Frame 0077;

WHEREAS, the 2022 Notice of Grant of Security Interest in Trademarks was recorded by the Trademark Division of the United States Patent and Trademark Office on January 4, 2023, at Reel 7900, Frame 0510;

WHEREAS, the 2023 Notice of Grant of Security Interest in Trademarks was recorded by the Trademark Division of the United States Patent and Trademark Office on February 16, 2023, at Reel 7972, Frame 0030;

WHEREAS, Grantor has requested that Agent release its lien in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby irrevocably terminates, releases and discharges the entirety of any and all liens or security interests that it may have, and all claims, whether presently existing or hereafter acquired or created, in, to and under all of Grantor’s respective right, title and interest in and to the Trademark Collateral (and any right, title or interest of Agent in such Trademark Collateral shall hereby terminate, cease and become void), including without limitation:

- (a) all of its Trademarks referred to on Schedule 1 hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including without limitation, all rights to

sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent, on behalf of itself and the Lenders, does hereby terminate and cancel the Trademark Security Agreement.

3. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in, to and under the Trademark Collateral. Agent hereby authorizes Grantor (or their designee) to file this Release with the United States Patent and Trademark Office.

4. The Agent shall take all further actions, on behalf of itself and the Lenders, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at the Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.

5. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

6. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
