FIRST: The name and state of organization or incorporation of each of the constituent entities are:

EIGHTH: The Surviving Corporation hereby undertakes to deliver the request for publication of a notice of filing this Certificate of Merger and payment therefor as required by Section

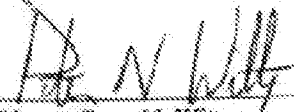

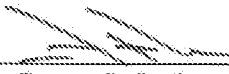
