## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this “**Assignment**”), effective as of January 23, 2020 (the “**Effective Date**”), is between SportsEngine LLC, a Delaware limited liability company (“**Assignor**”) and iScore Sports, Inc. a Delaware corporation (“**Assignee**”).


NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged:

1. Assignor hereby sells, conveys, transfers, assigns and delivers to Assignee all of its right, title and interest in, to and under the Assigned Trademark, together with the goodwill symbolized by and associated with the use of the Assigned Trademark.
2. Assignor hereby authorizes and requests the U.S. Commissioner of Patents and Trademarks and/or the applicable foreign authorities to record this Assignment.
3. Nothing contained in this Assignment supersedes, alters or modifies any of the provisions of the Asset Purchase Agreement. In the event of any conflict between the terms of this Assignment and the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall control.
4. This Assignment shall be governed by and construed in accordance with the law of the State of Delaware (and United States law, to the extent applicable), without regard to the conflicts of law rules of such state.
5. Assignor agrees to deliver to Assignee all such other documents and instruments reasonably required or relating to the transaction contemplated by this Assignment as Assignee may reasonably request or deem reasonably necessary in order to effectuate the transaction contemplated by this Assignment.


