PARTIAL TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS

This PARTIAL TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Partial Termination and Release"), dated as of March 31, 2023, is made by JPMORGAN CHASE BANK, N.A., in its capacity as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of VENATOR AMERICAS LLC, a Delaware limited liability company (formerly known as Huntsman P&A Americas LLC) (the "Grantor").

W I T N E S S E T H:

WHEREAS, pursuant to (a) the Term Loan Collateral Agreement, dated as of August 8, 2017 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Collateral Agent and (b) that certain Trademark Security Agreement, dated as of August 8, 2017 (the "Trademark Security Agreement"), among the Grantor, the Collateral Agent and the other grantors party thereto, as security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantor pledged to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, and granted to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest (the "Security Interest") in all of the Grantor's right, title and interest in or to the Trademark Collateral (as defined in the Trademark Security Agreement), including but not limited to those trademark registrations and applications set forth on Schedule A attached hereto (collectively, together with such Grantor's right, title and interest in, to and under the Trademark Collateral, the "Released Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 27, 2017 at Reel/Frame No. 6203/0266; and

WHEREAS, the Grantor has requested and the Collateral Agent has agreed to provide this Partial Termination and Release in order to terminate and release its Security Interest solely in the Released Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Partial Termination and Release, the Collateral Agent hereby agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein, terms used in this Partial Termination and Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement or the Trademark Security Agreement, as applicable.

SECTION 2. Release of Security Interest in Released Trademark Collateral. The Collateral Agent, without recourse, representation or warranty of any kind, hereby terminates, releases, discharges, and cancels all of its Security Interest in the Released Trademark Collateral arising under the Trademark Security Agreement or the Security Agreement, as applicable, and any right, title or interest of the Collateral Agent in the Released Trademark Collateral arising

under the Trademark Security Agreement or the Security Agreement, as applicable, shall hereby cease and become void.

SECTION 3. Partial Release. This Partial Termination and Release is applicable only and solely with respect to the Released Trademark Collateral and no other Trademark Collateral arising under the Trademark Security Agreement or the Security Agreement. Except as expressly modified hereby, the Trademark Security Agreement and the Security Agreement shall remain in full force and effect, each in accordance with the provisions thereof on the date thereof.

SECTION 4. Recordation. The Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Partial Termination and Release.

SECTION 5. Governing Law. EACH OF THE PARTIES HERETO HEREBY IRREVOCABLY AND UNCONDITIONALLY AGREES THAT ALL CLAIMS IN RESPECT OF ANY ACTION OR PROCEEDING ARISING OUT OF OR RELATING TO THIS PARTIAL TERMINATION AND RELEASE, OR FOR RECOGNITION OR ENFORCEMENT OF ANY JUDGMENT, SHALL BE HEARD AND DETERMINED IN SUCH NEW YORK STATE OR, TO THE EXTENT PERMITTED BY LAW, IN SUCH FEDERAL COURT.
