ASSIGNMENT OF INTELLECTUAL PROPERTY

This ASSIGNMENT OF INTELLECTUAL PROPERTY (this “Assignment”), is entered into and made effective as of March 11, 2022, by and among Specialty Program Group, LLC, a Delaware limited liability company (the “Assignee”), and the Persons set forth on the signature pages hereto under the heading “Assignors” (collectively, the “Assignors”).

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of February 24, 2022 (as amended, restated, or otherwise modified from time to time, the “Purchase Agreement”), by and among the Assignee and the Assignors, the Assignors have agreed to sell, assign, transfer, convey, and deliver to the Assignee, and the Assignee has agreed to purchase and acquire from the Assignors, all of each Assignor’s right, title, and interest in, to, and under the Intellectual Property owned by the Assignor, including, without limitation, (a) all rights of the Assignors to the Internet domain names set forth on Schedule A hereto (collectively, the “Domain Names”); (b) all rights of the Assignors to the trademarks, tradenames, service marks, and registrations set forth on Schedule B hereto (collectively, the “Trademarks”); and (c) all rights in any software in source or object code form, including configurations, interfaces, modifications, and other customizations thereto (“Proprietary Software”), if any, set forth on Schedule C and has agreed to execute and deliver this Assignment;

WHEREAS, the Assignee and the Assignors are hereby effecting such transfer and assignment of all right, title, and interest of the Assignors in and to the Intellectual Property, which includes the Domain Names the Trademarks and the goodwill associated with and symbolized by the Trademarks;

WHEREAS, capitalized terms used but not otherwise defined in this Assignment shall have the respective meanings ascribed to such terms in the Purchase Agreement; and

WHEREAS, this Assignment is being executed and delivered by the parties hereto in connection with the consummation of the transactions contemplated by the Purchase Agreement.

NOW, THEREFORE, in consideration for the execution of the Purchase Agreement, the payment of the consideration stipulated in the Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee and the Assignors hereby agree as follows:

1. Assignment. The Assignors hereby irrevocably convey, transfer and assign to the Assignee all right, title, and interest of the Assignors in and to the Intellectual Property owned by the Assignor, including, without limitation, all rights of the Assignors to the Proprietary Software, if any, the Domain Names, the Trademarks, together with all goodwill associated with the Trademarks, and all rights of the Assignors to sue and recover damages for past, present and future infringement, dilution, misappropriation or other violation of any rights associated with the Intellectual Property. The Assignee is to hold all right, title, and interest in and to the Intellectual Property, the Proprietary Software (if any), the Domain Names, and the Trademarks as fully and exclusively as they would have been held and enjoyed by the Assignors had the assignment in this Section 1 not been made.

2. Recording and Further Actions. The Assignors authorize and request the Assignee to take such action as may be required to cause the Assignee to be recorded as the assignee or transferee of the Proprietary Software (if any), the Domain Names, and the Trademarks, and shall, promptly upon presentation to the Assignors by the Assignee, execute, or procure the execution of, such transfer documents and provide such information as may reasonably be requested and required to cause the Assignee to be recorded as the assignee, registrant or transferee of the Proprietary Software (if any), the Domain Names, and the Trademarks.

3. Other Deliverables. The Assignors agree to promptly deliver to the Assignee or its legal counsel any additional documents or tangible things which the Assignee may reasonably request and relating to the investigation, evaluation, preparation, prosecution, maintenance, defense, filing, issuance, registration, assertion or enforcement of the Intellectual Property, the Proprietary Software (if any), the Domain Names, and the Trademarks.

4. Governing Law. This Assignment shall be governed by, and construed in accordance with, the substantive laws of the State of Illinois, without giving effect to any choice or conflict of law provision or rule that would cause the application of the law of any jurisdiction other than the State of Illinois.

5. Counterparts. This Assignment may be executed and delivered (including by “pdf” or other electronic transmission) in any number of counterparts, each of which shall be deemed to be an original instrument, and all of which together shall constitute one and the same agreement.

6. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

7. Headings. The headings contained in this Assignment are for convenience of reference only and shall not affect in any way the meaning or interpretation of this Assignment.

8. Relationship to Purchase Agreement. This Assignment is executed and delivered pursuant to, is in furtherance of, and is subject to the terms and conditions of, the Purchase Agreement. In the event of any conflict between the terms of the Purchase Agreement and the terms of this Assignment, the terms of the Purchase Agreement shall prevail. Nothing contained in this Assignment shall be deemed to alter, modify, expand or diminish the terms or provisions of the Purchase Agreement.


