**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of this 5th day of April 2023, by BROOKSIDE MEZZANINE FUND III, L.P., as agent ("Agent"), in favor of THE INFOSOFT GROUP LLC, a Wisconsin limited liability company (the "Grantor").

WHEREAS, Grantor entered into that certain Trademark Security Agreement, dated September 16, 2019 (the "Trademark Security Agreement"; capitalized terms used herein but not otherwise defined herein shall have the meanings assigned to such terms in the Trademark Security Agreement) with Agent, notice of which was recorded on September 16, 2019 at the United States Patent and Trademark Office (the "USPTO") at Reel 6745, Frame 0330;

WHEREAS, Grantor granted Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of Agent, in and to its Trademarks constituting Collateral, including without limitation the Trademarks listed in **Schedule A** (the "Trademark Collateral"); and

WHEREAS, Agent has agreed to terminate and release its Security Interest in all such Trademark Collateral as herein provided.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent, on behalf of itself and the Lenders, hereby (a) releases all security interests, lien and mortgage, and right of setoff granted by Grantor in favor of Agent in, to and against the Trademark Collateral, including the Trademarks listed on **Schedule A** attached hereto and (b) reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest (if any) in and to the Trademark Collateral.

Agent authorizes and requests that the USPTO and any applicable governmental officer record this Release.

Agent agrees, at the Grantor's sole cost and expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including without limitation, the execution and delivery of any and all further documents or other instruments, as either Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


This Release and the rights and obligations of the parties hereto shall be governed by, and construed in accordance with, the laws of the State of New York.
