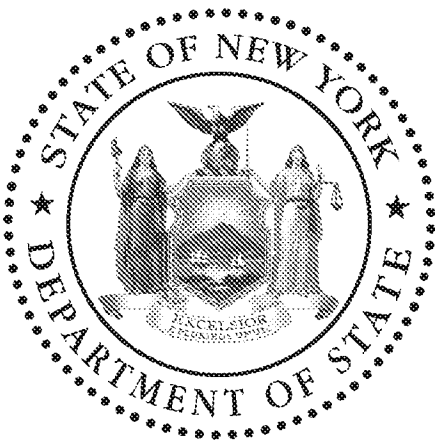

Under Section 1003 of the Limited Liability Company Law

1. The name (and, if the name has been changed, the name under which it was formed) and jurisdiction of formation or organization of each limited liability company or other business entity that is to merge is:

Flaghouse, Inc., a New York corporation (the "Merging Entity").

Flaghouse Transition, LLC, a New York limited liability company (the "Surviving Company").
2. For each domestic limited liability company and domestic other business entity, the date when its initial articles of organization or formation document was filed with the Department of State of the State of New York (the "Department of State") is as follows:

The Merging Entity filed its initial Certificate of Incorporation on January 18, 1954.


The Surviving Company filed its initial Articles of Organization on January 6, 2023.

The address within or without the State of New York to which the Secretary of State shall mail a copy of any process against the Surviving Company served upon the Secretary of State is 601 Flaghouse Drive, Hasbrouck Heights, New Jersey 07604.
6. The agreement of merger is on file at the Surviving Company's place of business located at 601 Flaghouse Drive, Hasbrouck Heights, New Jersey 07604.
7. The Surviving Company will furnish a copy of the agreement of merger upon request and without cost to any member of any domestic limited liability company or any person holding an interest in the Merging Entity.
