TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of March 30, 2023 (the "Release"), from **CIBC BANK USA**, as administrative agent for itself and the Lenders party to the Credit Agreement described below (in such capacity, together with its successors and assigns, the "Administrative Agent"), to **SHIPPERT ENTERPRISES, LLC**, a Delaware limited liability company and **SUMMIT MEDICAL, LLC**, a Minnesota limited liability company (individually each referred to herein as a "Grantor" and collectively referred to herein as "Grantors").

W I T N E S S E T H:

WHEREAS, pursuant to the Credit Agreement dated as of August 25, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and that certain Guaranty and Collateral Agreement dated as of August 25, 2020 (as amended, restated, supplemented, reaffirmed or otherwise modified from time to time, the "Guaranty and Collateral Agreement"), Grantors granted to the Administrative Agent a security interest (the "Security Interest") in certain collateral;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of August 25, 2020 (the "Trademark Security Agreement"), by and between the Administrative Agent and Grantors, Grantors, by reference to the Credit Agreement and the Guaranty and Collateral Agreement, reaffirmed their intent to grant to the Administrative Agent the Security Interest specifically in the Trademark Collateral (as specified in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 25, 2020 at Reel 7035 and Frame 0284; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral, including the items of Trademark Collateral set forth on Schedule A attached hereto and made a part hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement and the Loan Documents (defined in the Credit Agreement), as applicable.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases, and discharges, without recourse, representation, or warranty, its Security Interest in the Trademark Collateral, including:

(a) each Trademark and application for Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(b) all products and proceeds of the foregoing, including without limitation, any claim by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark,

and any right, title, or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void. The Administrative Agent reassigns to the Grantors any and all such right, title, and interest (if any) that the Administrative Agent may have in, to, and under the Trademark Collateral.

3. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of Illinois.
