VACATION INNOVATIONS, LLC, a Delaware limited liability company, TIMESHARE PARTNERS, LLC, a Florida limited liability company, TIMESHAREWEB.COM, LLC, a Florida limited liability company, and VACATIONOWNERSHIP.COM, LLC, a Florida limited liability company (collectively, the "Borrowers") and Comerica Bank as Administrative Agent and the lenders from time to time party thereto have previously entered into that certain Credit Agreement dated March 26, 2018, as the same has been amended, supplemented, amended and restated or otherwise modified from time to time (the "Existing Credit Agreement").
- In connection with the Existing Credit Agreement, Assignor is party to (i) that certain Intellectual Property Security Agreement dated as of March 26, 2018 executed by Carefree Exchange, LLC, a Florida limited liability company, Carefree Journeys, LLC, a Florida limited liability company, CJ Timeshares, LLC, a Florida limited liability company, Nerdsoft, LLC, an Arkansas limited liability company, Quid, LLC, a Florida limited liability company, Resort Owner's Club, LLC a New Mexico limited liability company, Resortrentals.com, LLC, a Florida limited liability company. RNR Management, LLC, a Florida limited liability company, SMTN.Com, a New Hampshire limited liability company, Strategis Realty, LLC, a Florida limited liability company, Timeshare Closing Services, LLC, a Florida limited liability company, Travel Research Partners, LLC, a Florida limited liability company, VI Network, LLC, a Florida limited liability company, Vacation Ownership Brokerage LLC, a Florida limited liability company, and Vesco Services, LLC, a Florida limited liability company (collectively, the "Original Guarantors"), Borrowers, certain other parties thereto, and the Assignor, as recorded under Reel No. 006324 Frame No. 0464 on May 1, 2018 with the U.S. Patent and Trademark Office and (ii) that certain intellectual Property Security Agreement dated as of September 3. 2020 executed by Holiday Systems International of Nevada, LLC, a Delaware limited liability company ("HSIN", together with the Original Guarantors, the "Guarantors"; such Guarantors together with the Borrowers referred to herein as the "Owners") and Assignor as recorded under Reel No. 7075, Frame No. 0696 on September 4, 2020 with the U.S. Patent and Trademark Office (as each may have been amended, restated or modified from time to time, the "Existing IP Security Agreements").
- C. Pursuant to the Existing IP Security Agreements, the Owners have granted to the Assignor a lien on and security interest in certain collateral described therein, including without limitation, those on Exhibits A, B and C attached hereto (collectively, the "IP Collateral").
- D. Assignor has agreed to sell and assign its interest in the Existing Credit Agreement and the Loan Documents (as defined therein) (as defined therein) to the Assignee by entering into that certain Assignment of Obligations and Liens dated as of the date hereof (as the same has been or may be amended, restated or modified from time to time, the "Assignment Agreement"), including any and all liens on and security interest in the IP Collateral.
- NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are thereby acknowledged, and subject to the terms and conditions of the Assignment Agreement, the parties hereto agree as follows:
- 1. <u>Assignment</u>. The Assignor has TRANSFERRED, ASSIGNED, GRANTED and CONVEYED and do by these presents TRANSFERS, ASSIGNS, GRANTS and CONVEYS unto Assignee the Existing IP Security Agreements, together with all, if any, rights, titles, assignments and interests pertaining to or arising from the Existing IP Security Agreements (collectively the "<u>Assigned Documents</u>").
- 2. <u>Miscellaneous</u>. (a) This Assignment cannot be altered, amended or modified in any way, except by a writing signed by Assignee and Assignor. (b) This Assignment is supplemental to, and not in derogation of or substitution for, all other Loan Documents granting to Assignee a security interest or lien in the IP Collateral, and the rights of Assignee under this Agreement shall be supplemental to and cumulative of all such other grants of a security interest and Loan Documents. (c) This Assignment shall be binding upon Assignor and its successors and permitted assigns, and shall inure to the benefit of Assignee and its respective successors and assigns. (d) THIS ASSIGNMENT SHALL, EXCEPT TO THE EXTENT THAT THE LAWS OF ANOTHER JURISDICTION APPLY TO THE IP COLLATERAL OR ANY PART THEREOF, BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS, EXCEPT AS TO CONFLICTS OF LAWS, AND THE APPLICABLE LAWS OF THE UNITED STATES OF AMERICA. (e) By receiving this Assignment, Assignee is entitled to receive all of the benefits and none of the obligations and liabilities which may arise from the Existing IP Security Agreements.

If Lender determines in its reasonable discretion that this Amendment or any Loan Document has not been timely executed by any of the Borrowers, Guarantors or Subordinated Creditors, this Amendment or any related Loan Document contained in the associated Docusign envelope, will be nullified and voided and such Loan Documents will need to be updated and resent upon terms and conditions satisfactory to all parties. Each of the Borrowers, Guarantors and Subordinated Creditors, in connection therewith. Notwithstanding the foregoing, Lender may require original manually executed signatures.


