ASSIGNMENT OF TRADEMARKS

ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE, its successors and assigns its entire right, title and interest in and to the TRADEMARKS, together with all applications and registrations therefore, the benefit of any use of the TRADEMARKS, and with the goodwill of the business associated with the TRADEMARKS, all common law rights related thereto, all rights of registration, renewal and extension;

ASSIGNOR does also hereby sell, assign and transfer unto ASSIGNEE, its successors and assigns all claims for damages by reason of past and present infringement of the TRADEMARKS, including the trademark rights established by use, the registrations and applications, and the right to sue for and collect damages and other relief;

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States to record the right to the TRADEMARKS as the property of ASSIGNEE, and ASSIGNOR further agrees to execute such further documents as may be required in the United States to record and/or establish ASSIGNEE as the owner of the TRADEMARKS, and all rights herein assigned.

IN WITNESS WHEREOF, the parties duly execute this Agreement by their authorized representatives, made effective back to the date of 4/7/2023.




