Assignor hereby grants and assigns to the Assignee its entire right, title, and interest in and to the Trademarks, together with all goodwill associated therewith, including but not limited to all U.S. rights to use the Trademarks as well as all worldwide rights to use the Trademarks and to file for foreign trademark registrations.
2. Assignee accepts all such rights, titles and interest.
3. Assignor hereby represents and warrants as follows:
 - (a) Assignor is a Hong Kong company;
 - (b) Assignor is the owner of the Trademarks, and no rights or equity of any third party is or will be prejudiced due to this assignment, transfer and use of the Trademarks. To the best of Assignor's knowledge, there are no litigation or other disputes or claims arising from or relating to any of the Trademarks; and
 - (c) Assignor has the full authority and corporate power to make the assignment hereunder, and has obtained all consents and approvals from shareholders, third parties or governmental/regulatory bodies as required to execute and perform this Assignment, in accordance with all applicable laws.



5. This Assignment shall be binding on all parties, their heirs, successors, and assigns, and may be recorded in the United States Patent and Trademark Office and under the appropriate state provisions of the Uniform Commercial Code.


