5. The plan of conversion has been approved in accordance with all applicable statutes, including all applicable provisions of the Florida Business Corporation Act.

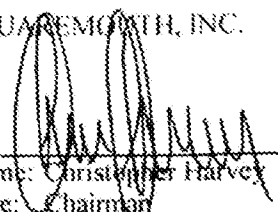
