RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TERMINATION OF SECURITY INTEREST

Reference is hereby made to that certain Amendment to Security Agreement, dated as of November 3, 2011 (the "Amendment"), executed by JBJ HOLDING, INC., a California corporation (and subsequently reincorporated as a Delaware corporation) and JR KINDER'S ENTERPRISES, INC., a California corporation, P.K. KINDER CO., INC. whose address is: 2121 N. California Boulevard, Suite 405, Walnut Creek, CA 94596 (collectively, the "DEBTOR") and PAULA K. KINDER, TRUSTEE OF THE PAULA K. KINDER LIVING TRUST; DAN R. KINDER, TRUSTEE OF THE DANNY RAY KINDER LIVING TRUST; PAULA KINDER, ADMINISTRATOR OF THE ESTATE OF JACOB DANIEL KINDER; AND JUSTIN STEWART KINDER whose address is 1150 Burnett Avenue, Suite D, Concord, CA 94520 (collectively, the "SECURED PARTY") which amended the Security Agreement dated August 27, 2007 ("Security Agreement) among JBJ Holding, Inc., and JR Kinder's Enterprises, Inc., and SECURED PARTY.

The Amendment was recorded in the United States Patent and Trademark Office on December 1, 2011, at Reel 004669 and Frame0276, et seq., and pursuant to which the DEBTOR granted to SECURED PARTY, a security interest in, and lien upon all of DEBTOR'S right, title and interest in and to certain trademarks, including those trademarks specifically listed on Exhibit A attached hereto (the "MARKS") and the goodwill associated therewith; and

WHEREAS, SECURED PARTY wishes to terminate the Amendment and release, retransfer and reassign to DEBTOR, without representation or warranty, all of SECURED PARTY'S right, title and interest in and to the MARKS and the goodwill associated therewith.
