**TRADEMARK ASSIGNMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree that as of June 5, 2022, Assignor assigned and transferred *nunc pro tunc*, and does hereby assign and transfer, the Application and the Mark, and all corresponding international and foreign rights associated therewith, and any and all trademark rights that Assignor may have in marks including the words TRANCE or confusingly similar terms or phrases, and all goodwill to which any of these (including but not limited to the Application in the Mark) pertain, to Assignee, Assignee being the successor to all goodwill and business associated with any and all of these (including but not limited to the Application and the Mark).

Assignor authorizes the Commissioner of Trademark of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the Mark and/or the Application to Assignee as assignee of Assignor's entire right, title, and interest therein; and Assignor hereby agrees to execute such further documents as Assignee may deem necessary to perfect and/or record the transfer of rights to Assignee.
