**TERMINATION AND RELEASE  
OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT ("*Termination and Release*") dated as of April 6, 2023, is made by WESTERN ALLIANCE BANK, an Arizona corporation ("*Lender*") in favor of Verisma Systems, Inc., a Delaware corporation ("*Grantor*").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of May 19, 2017, by and among Lender and Grantor (the "*Security Agreement*"), a security interest was granted by Grantor to Lender in certain collateral, including intellectual property collateral;

WHEREAS, the Security Agreement was recorded (i) with the Patent division of the United States Patent and Trademark Office ("*USPTO*") on May 19, 2017, at Reel 042436 and Frame 0845, and (ii) with the Trademark division of the USPTO on February 2, 2023 at Reel 007972 and Frame 0251 (iii) with the Trademark division of the USPTO on May 19, 2017 at Reel 006063 and Frame 0743; and

WHEREAS, Lender now desires to terminate and release its security interest (as applicable) in the intellectual property listed on Schedules A and B attached hereto, respectively, and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby irrevocably releases, discharges and terminates its lien on and security interest in (as applicable) all of Grantor's right, title and interest in and to the intellectual property set forth on Schedules A and B attached hereto.

2. If and to the extent that Lender has acquired any right, title or interest in or to any of the intellectual property set forth on Schedules A and B, Lender hereby reassigns, grants and conveys to Grantor, in each case without any representation, warranty, recourse or undertaking by Lender, any and all of Lender's right, title, and interest in and to the intellectual property set forth on Schedules A and B attached hereto.

3. Lender authorizes and requests that the Commissioner of the USPTO and any other applicable government authority record this Termination and Release.
