## Intellectual Property Security Agreement

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of MARCH 31, 2023 (this "Agreement"), is made by MCCALL FARMS, INC., a South Carolina corporation (the "Grantor"), in favor of TRUIST BANK, a North Carolina banking corporation (the "Secured Party" as defined in the Security Agreement referred to below).

### RECITALS

WHEREAS, the Grantor and Secured Party have entered into a Loan Agreement, dated as of March 31, 2023 (as amended, restated, supplemented, replaced, increased, refinanced or otherwise modified from time to time, the "Loan Agreement"); and

WHEREAS, in connection with the Loan Agreement, the Grantor entered into a Security Agreement, dated as of March 31, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Secured Party; and

WHEREAS, the Security Party requires the Grantor to execute and deliver this Agreement.

### AGREEMENT

NOW, THEREFORE, in consideration of the premises and in order to ensure compliance with the Loan Agreement and Security Agreement, the Grantor hereby agrees as follows:

**Section 1** Defined Terms. Capitalized terms used herein without definition are used as defined in the Loan Agreement or Security Agreement.

**Section 2** Grant of Security Interest in Intellectual Property Collateral. The Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of the Grantor, hereby pledges, assigns and transfers to the Secured Party, and grants to the Secured Party a security interest in, all of its right, title and interest in, to and under the following Collateral (the "IP Collateral"):

- (i) all of its Copyrights and all Copyright Licenses providing for the grant by or to the Grantor of any right under any Copyright, including, without limitation, those referred to on Schedule I hereto, and all renewals, reversions and extensions of the foregoing;
- (ii) all of its Patents and all Patent Licenses providing for the grant by or to the Grantor of any right under any Patent, including, without limitation, those referred to on Schedule I hereto, and all reissues, reexaminations, continuations, continuations-in-part, divisions, renewals and extensions of the foregoing;
- (iii) all of its Trademarks and all Trademark Licenses providing for the grant by or to the Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule I hereto, and all renewals and extensions of the foregoing;

- (iv) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (v) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment of any of the foregoing IP Collateral.

**Section 3 Guaranty and Security Agreement.** The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Secured Party pursuant to the Security Agreement, and the Grantor hereby acknowledges and agrees that the rights and remedies of the Secured Party with respect to the security interest in the IP Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any conflict or inconsistency between this Agreement and the Security Agreement (or any portion hereof or thereof), the terms of the Security Agreement shall prevail.

**Section 4 Representation and Warranty.** Schedule I correctly sets forth all applied for and federally registered Copyrights and exclusive Copyright Licenses, Patents and Trademarks owned by such Grantor in its own name as of the date hereof.

**Section 5 Grantor Remains Liable.** The Grantor hereby agrees that, anything herein to the contrary notwithstanding, the Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with its Copyrights, Patents and Trademarks and Copyright Licenses, Patent Licenses and Trademark Licenses subject to a security interest hereunder.

**Section 6 Counterparts.** This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.


