The undersigned, an authorized natural person, for the purpose of forming a limited liability company pursuant to the Limited Liability Company Act of the State of Delaware, hereby certifies that:

**FIRST:** The name of the limited liability company (hereinafter called the "limited liability company") is:

**THIRD:** National Football League policy has limitations on the number and type of persons who may have ultimate direct, indirect, beneficial, contingent or other interests in the Tennessee Titans franchise and related assets (the "Franchise") and prohibits any direct or indirect sale, transfer, assignment, pledge, hypothecation, encumbrance or other disposition of, or with respect to, the Franchise or any direct or indirect interest therein without the prior written consent of the National Football League, unless specifically exempted from such consent pursuant to the Constitution and Bylaws of the National Football League. Please contact the National Football League, League Counsel, 345 Park Avenue, New York, New York 10154 to determine the applicable requirements.

**FOURTH:** The effective time and date of this Certificate of Formation shall be 11:52 p.m. Eastern time of March 31, 2023.
