SIXTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation, on request and without cost, to the member of the merging limited liability company.


SEVENTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
