
### AGREEMENT

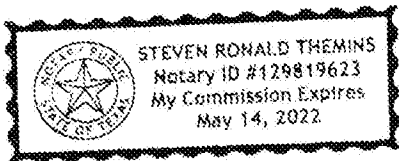
