**IP assets and rights (Formula, Mold, Trademarks and domain names) Assignment Agreement**

This agreement (hereinafter referred to as the "Assignment") is made and entered by and between the following parties:

(the "Assignor")

AND

**DAVIDE CAMPARI – MILANO N.V.**, with registered office in Amsterdam, Netherlands and corporate office at Via F. Sacchetti n. 20, Sesto San Giovanni (Milan), Italy represented by its Managing Director, Mr. Paolo Marchesini, pursuant to Board of Directors resolution dated 16 December 2021,

(the "Assignee")

WHEREAS, the Assignor is the sole and rightful owner of the Bulldog trademarks (whether registered or unregistered and including all copyright and design rights associated with them) /domain names and/or service marks and the corresponding registrations and/or applications for registration set forth in Exhibit A attached hereto as well as the formula and mold of Bulldog product; (collectively referred to as IP assets) and

WHEREAS, the Assignee desires to purchase or acquire the Assignor's right, title, and interest in IP assets, domain names, formula and mold; and

WHEREAS, the Assignor and Assignee are both duly authorized and capable of entering into this Assignment.

NOW, THEREFORE, for valuable consideration, the receipt of which is acknowledged, the parties hereto agree as follows:

**1. ASSIGNMENT**

The Assignor does hereby sell, assign, transfer and set over to Assignee all of its right, title and interest in and to the IP assets in the world and all jurisdictions of the world, with full title guarantee (including, without limitation, the right to sue and recover for any past or continuing infringements or contract breaches related to the trademarks, the right to renew any registrations included in the trademarks, the right to apply for trademark registrations based in whole or in part upon the trademarks, and any priority right that may arise from the trademarks, but excluding any goodwill of the Assignor's business that relates to the IP

assets), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

The Assignor authorizes the Trademark Agent engaged by Assignee and all Trademark Office and any other applicable to record the transfer of the registrations and/or registration applications set forth in Exhibit A to Assignee as the recipient of Assignors entire right, title, and interest therein.

Assignor further agrees to upon the request and at the expense of Assignee: (a) cooperate with Assignee in the protection of the trademark rights and prosecution and protection of foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including registration applications and instruments of transfer; and (c) perform such other acts as Assignee lawfully may request to obtain or maintain the Trademarks and any and all applications and registrations for the trademarks.

## 3. EFFECTIVE DATE

The Assignment will be effective as of December 31, 2021 (the "Effective Date").

## 4. WARRANTY

Assignor warrants that Assignor is the legal owner of all right, title, and interest in the IP assets and that they have not been previously pledged, assigned, or encumbered.

## 5. GOVERNING LAW

This Assignment is governed by and is to be construed in accordance with the laws of Scotland and will be subject to the non-exclusive jurisdiction of the Scottish courts.

## 6. MISCELLANEA

If one or more provisions of this Assignment are held to be unenforceable under applicable law, the parties agree to renegotiate such provision in good faith. If the parties cannot reach a mutually agreeable and enforceable replacement for such provision, then (i) such provision will be excluded from this Assignment,
