INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (SHORT FORM)

This Intellectual Property Assignment Agreement (this "Agreement") is made and entered into as of October 21, 2022, by and among ESPN Productions, Inc., a Delaware corporation ("ESPN Productions"), ESPN, Inc., a Delaware corporation ("ESPN"); each of ESPN and ESPN Productions, an "Assignor" with respect to the applicable Assigned Intellectual Property owned by each respective entity, and together, "Assignors"), and Sports Content Creation LLC, a Delaware limited liability company ("Assignee" and, together with Assignors, the "Parties").

WHEREAS, Assignors own certain trademark registrations and applications set forth on Attachment A hereto (the "Assigned Trademarks") and certain domain names set forth on Attachment B hereto (the "Assigned Domain Names"); and

WHEREAS, each Assignor has agreed to irrevocably transfer, convey and assign to Assignee, all of such Assignor's right, title and interest in and to the applicable Assigned Trademarks and Assigned Domain Names (collectively, the "Assigned Intellectual Property").

NOW, THEREFORE, in consideration of the foregoing and the covenants and agreements contained in this Agreement, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Conveyance. Each Assignor does hereby irrevocably contribute, convey, grant, transfer, assign and deliver, to Assignee, its entire worldwide right, title and interest in and to the Assigned Intellectual Property. Each assignment hereunder includes all associated and ancillary rights with respect to the Assigned Intellectual Property and all goodwill associated with and symbolized by the applicable Assigned Intellectual Property, including but not limited to (a) all claims and causes of action (either in law or equity), including the right to sue, counterclaim, and recover for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach or default, unfair competition, or other violation of the Assigned Intellectual Property; (b) all income, royalties, fees, damages, payments, and other proceeds now or hereafter due or payable with respect to the Assigned Intellectual Property; (c) all rights to apply for, revive, obtain and maintain all registrations, renewals and/or extensions of the Assigned Intellectual Property; (d) all rights to grant licenses or other interests therein; and (e) all other rights corresponding to the Assigned Intellectual Property throughout the world, as fully and entirely as the same would have been held and enjoyed by Assignors within the applicable territory if this conveyance had not been made, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.

2. Due Authorization. Each Assignor hereby authorizes and requests any official of any applicable governmental authority to issue any and all registrations from any and all applications for registration included in the Assigned Trademarks (and, where applicable, the Assigned Domain Names) to and in the name of Assignee.





{Signature Page to Intellectual Property Assignment Agreement (Short Form)}

On March 22, 2023, the Assignments Branch of the United States Patent and Trademark Office examined and found non-recordable an assignment filed on March 10, 2023 to record assignment of X GAMES and Design (Reg. 4206393) from ESPN, Inc. to Sports Content Creation LLC. Recordal was refused on the basis that there is a discrepancy with the conveying party name in that the conveying name ESPN Productions, Inc is missing from the cover sheet.

Sports Content Creation respectfully submits that the cover sheet is accurate. The Intellectual Property Assignment Agreement that is being recorded assignments intellectual property from each of ESPN, Inc. and ESPN Productions, Inc. to Sports Content Creation LLC for, among other things, trademark applications and registrations globally. In the United States, the relevant trademark applications and registrations that were assigned are owned in the name of ESPN, Inc. and not ESPN Productions, Inc. Therefore, the cover sheet accurately reflects the assignor of the US trademarks.

We note that this same Intellectual Property Assignment Agreement was filed and recorded against the remaining United States trademark applications and registrations covered by the assignment. On the cover sheet, the assignor is properly reflect as just ESPN, Inc., and that assignment was recorded on March 15, 2023 by the Assignments Branch at Reel/Frame: 8004/0352.

Sports Content Creation LLC therefore requests that the Assignments Branch record the assignment of Reg. 4206393 as filed.
