Marks, including the applications and registrations thereof and the Certificates of Registration duly and legally issued therefor, and any and all renewals thereof for the Marks, together with the goodwill of the business symbolized thereby in such countries and in connection with such Marks as is deemed necessary by ASSIGNEE, and further including, without limitation, all claims for damages by reason of past infringement and the right to sue for and the right to collect the same for its own use and behoof, and for the use and behoof of its successors, assigns, or legal representatives and the right to defend the Marks and the applications and registrations thereof.

ASSIGNOR represents that: (i) it is the owner of all rights, title, and interests in and to the Marks and that it has the authority to make this Master Assignment; (ii) there are no current or effective licenses, assignments, security interests, or other encumbrances of or relating to the Marks; and (iii) it knows of no other person or entity which has the right to use, or has made any claim pertaining to the right to use the Marks.

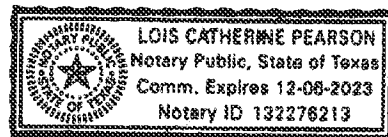

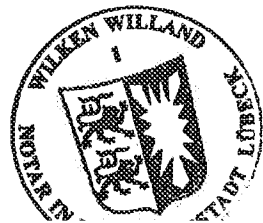
