**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Release of Intellectual Property Security Agreement (this “**Release**”) is made and effective as of April 13, 2023, by Acquiom Agency Services LLC, as collateral agent (in such capacity, the “**Agent**”), in favor of United Road Services, Inc., Fleet-Car Lease, Inc., and United Road Logistics LLC (each a “**Grantor**” and collectively, the “**Grantors**”). Capitalized terms used herein that are not otherwise defined shall have the meaning as defined in the Credit Agreement or the Intellectual Property Security Agreement (both defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Priming Term Loan Credit Agreement, dated as of February 24, 2023 (the “**Credit Agreement**”), among the Parent Borrower, Subsidiary Borrower, Holdings, the Lenders party thereto and the Agent, Grantors have granted to the Agent a security interest in all of their Intellectual Property upon the terms and subject to the conditions set forth therein; and

WHEREAS, pursuant to the Credit Agreement, Grantors and Agent entered into that certain Intellectual Property Security Agreement February 24, 2023 (the “**IP Security Agreement**”) wherein Grantors granted to Agent a security interest in all of Grantors’ right, title, and interest in and to the Patent Collateral and Trademark Collateral, including without limitation the Patents, Trademarks and applications set forth on **Schedule A** hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Agent hereby agrees and declares as follows:

1. Agent (a) hereby terminates the IP Security Agreement and releases its security interest in and Lien upon each Grantor’s right, title, and interest in and to the Patents, Trademarks, Patent Collateral, and Trademark Collateral, including those set forth on **Schedule A** hereto (b) shall, upon the Grantors’ or their respective nominee’s reasonable request and at the Grantors’ sole cost and expense, take all actions reasonably necessary to record with the USPTO or otherwise effectuate the purposes of this Release and (c) hereby authorizes each Grantor or their respective nominee to record this Release with the Commissioner for Patents and the Commissioner for Trademarks and/or any other applicable government officer.

2. Agent hereby reassigns, grants, and conveys to each Grantor, without any representation, recourse or undertaking by Agent, any and all right, title, and interest that Agent may have obtained in and to the Patents, Trademarks, Patent Collateral, and Trademark Collateral under the IP Security Agreement and the Credit Agreement.
