RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") dated as of April 14, 2023 is executed by BANK OF AMERICA, N.A., as lender for the benefit of the Secured Parties (in such capacity, the "Lender"), in favor of CANIDAE, LLC, a Delaware limited liability company (the "Grantor"). B. WHEREAS, Notice was recorded in the United States Patent and Trademark Office (the "USPTO") on December 17, 2019, at Reel 6818, Frame 0205, with respect to the Trademarks listed on Exhibit A attached hereto; and

C. WHEREAS, Grantor has requested that Lender release its security interests in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby terminates the Notice, and terminates and releases the continuing security interest in, and the right to set off against, any and all right, title and interest of Grantor in and to the Released Collateral, including the Trademarks listed on Exhibit A hereto, granted pursuant to the Security and Pledge Agreement or Notice.

Lender acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. Lender authorizes the recordation of this Release with the USPTO and other applicable registry at the sole expense of the Grantor.


