TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** (this "**Assignment**") is made and effective as of the 13th day of August, 2022 (the "**Effective Date**"), by and between **WPP Properties**, a partnership organized under the laws of the State of Delaware, USA, with an address at 3 World Trade Center, 175 Greenwich St., New York, NY 10007 USA ("**Assignor**") and **Johannes Leonardo, LLC**, a limited liability company of State of Delaware, USA, with an address at 115 Broadway, New York, NY 10006 USA ("**Assignee**").

WHEREAS, Assignor is the sole and exclusive owner of the right, title, and interest in and to the trademarks listed in Exhibit A attached hereto, including the U.S. registration and application, and the EU and UK registrations listed therein (hereinafter, collectively referred to as the "**Marks**"); and

WHEREAS, Assignee desires to acquire from Assignor, and Assignor agrees to transfer and assign to Assignee, all of Assignor's right, title, and interest in and to the Marks, together with the goodwill of the business connected with the use of and symbolized by the Marks.

NOW THEREFORE, for the sum of 1 USD and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee, intending to be legally bound, agree as follows:

Assignor hereby transfers and assigns to Assignee, and Assignee hereby accepts the transfer and assignment of (i) all of Assignor's right, title, and interest in and to the Marks, together with the goodwill symbolized by the Marks, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors and assigns, and (ii) all rights of Assignor to bring actions and proceedings, whether at law or in equity, against any third party for infringement, other misuse, registration or attempted registration of the Marks, including the right to bring an action for past, present, and future infringement, dilution, unfair competition, or other misappropriation or misuse, and all rights to recover damages, profits, attorneys' fees, and injunctive relief for infringement, dilution, unfair competition, or other misappropriation or misuse.

Assignee shall be permitted to record this Assignment or any similar assignment documents with the USPTO, the UKIPO, the EUIPO, and other relevant trademark offices outside the U.S. Assignor will fully cooperate with Assignee in executing such additional documents as may be reasonably necessary to give full to this assignment.
