Articles of Organization

Pursuant to KRS 14A, KRS 275, and KRS 275.476, the undersigned applies to qualify and for that purpose submits the following statements:

Article I: The name of the limited liability company is Commonwealth Brands, LLC.

Article II: The street address of the limited liability company's initial registered office in Kentucky is 421 West Main Street, Frankfort, Kentucky 40601, and the name of the initial registered agent at that office is Corporation Service Company.

Article III: The mailing address of the limited liability company's initial principal office is 714 Green Valley Road, Greensboro, North Carolina 27408.


Article IV: The limited liability company is to be managed by it member(s).
